In the summer of 2022, the First Nations Internal Techs hosted their youth engagement workshop for participants ages 13 to 17 in Fond Du Lac, Hatchet Lake, and Black Lake. A workshop focused Denesuline culture, traditional, and language heritages through practices, verbal, and direct instruction taught by the community's local land users and Elders. An applied practice that will enable the youth to have knowledge and skills about living off the land, local animal habitats, plant identifications, land marks, oral stories, and survival skills for future awareness

Chief Negotiator of North of 60. legal counsel. staff, and Trust lawyer and advisor will meet with the three Athabasca Leadership & Elders in Fond Du Lac to review the final steps needed to complete the draft North of 60 agreement and Trust.



We welcome our new Community Communications Coordinators:


Gloria Joseyounen of Hatch- three children.






